The organization's mission is to promote and strengthen a culture of active and progressive social change by supporting emerging and transformational leaders to confront successfully the most pressing social issues.

The "Colabora" Program aims to strengthen Latin America's economies by supporting youth-led businesses or social enterprises that are tackling pressing social issues, principally unemployment. This program educates young entrepreneurs on generating economic opportunities for themselves and others by applying market-oriented strategies. The project uses innovative ways to support new micro-enterprises or social initiatives through collaborative work, creating a supportive environment for young entrepreneurs and providing seed funding. Project participants are rigorously selected from a growing pool of candidates through our grantees and partners. Those selected benefit from training in business plans, access to valuable new connections, and joining a collaborative peer network. Under this program, forty young people are beneficiaries of a comprehensive fellowship program which includes participation in an in-depth Bootcamp to accelerate their ventures, receiving long-term mentoring, seed capital or stipends, and a comprehensive wellness support program over seven months. All participants rated the program highly, and a considerable percentage reported positive acceleration of their social or business ventures.

4b (Code: ) (Expenses \$ 55,619.01 including grants of \$ 47,148.21 (Revenue \$ 55,717.21)

The project "Supporting Youth At-Risk in Schools" is a social intervention program aimed at helping at-risk youth from getting affected by violence or involved in crime. The objective is to prevent crime and violence in schools by assisting graduating students to find meaningful employment and act as agents of peace. The methodology of this program is centered on strengthening the skills and emotional capabilities of young people to build a culture of peace in their educational, family, and community spheres while finding jobs that keep them from getting involved in criminal activities and violence. Under this project, seven public schools were chosen to participate. One hundred students at risk benefited from job training workshops, interactive training processes on peaceful conflict resolution, and courses to learn about different approaches to social change and ways to become positive change agents in their schools and communities.

4c (Code: ) (Expenses \$ 62,308.47 including grants of \$ 62,308.47 (Revenue \$ 40,000.00)

The program "Young Emerging Leaders for the Future of Democracy" aims to build a network of young pro-democracy leaders who can provide, in the medium and long term, innovative, systemic, and networked responses to deficits of democracy in Latin American. This project's beneficiaries are expected to contribute, participate, and lead a process to build more robust, more transparent, and participatory democratic institutions in their countries. The project started in July of 2021, and it is still being implemented. We identified 120 young leaders, of which 20 top emerging leaders were selected through a rigorous process. These emerging leaders participated in a one-year program and received a small stipend for five months to help them dedicate time to this opportunity. The training program includes workshops and curricula to strengthen their capabilities as transformative and empathic democratic leaders and teach them about the fundamentals of democracy and how to get involved in the political process.
